Notes Regarding 2024 Fees

GENERAL

1. Fields failing to pass on the first inspection may be reinspected if specifically requested by the applicant. Timing of reinspections is dependent upon the Inspector's work schedule, and the following fee schedule will apply:

	<u>1st Field</u>	<u>Additional Fields</u>
1 st reinspection	\$50.00	\$35.00
2 nd reinspection	\$125.00	\$35.00
Subsequent reinspections	\$150.00	\$35.00

2. Seed Laboratory fees are not included in the Certification Fees.
3. Carryover seed for which certification has not been completed but is eligible for certification must be reported to the New York Seed Improvement Project. Refer to **Section 96.16** of the General Standards.
4. Sampling of Certified Seed must be done under a current Compliance Agreement. Foundation and Registered Seed for resale must be sampled by the Certifying Agency. Please call to schedule arrangements. **Sampling Fee \$35.00.**

FORAGE CROPS

1. Applicants for Birdsfoot Trefoil or Red Clover who plan to clip or take a first cutting for hay and harvest the regrowth for seed should file the application for field inspection by July 1st indicating their intentions. Applicants are responsible for notifying the NYSIP office when fields are approaching full bloom. A service charge of \$27.50 will be assessed on forage applications received after July 1st.

POTATOES

1. Twelve cents per tag is charged for all potato certification tags.
2. The maximum charge for each winter test sample is estimated to be \$ **TBD.**
